THEY WILL CLEARCUT OTTAWA'S GREAT FOREST. WHY YOU SHOULD CARE:

- Cutting began Monday January 31st, against mass public opposition but with the approval of the City of Ottawa.
 KNL Developments, a collaboration between Urbandale and Richcraft, is responsible for this destruction.
- The Forest is an old-growth forest in Ottawa's most biodiverse region, with trees which survived the 1870 fire that razed Carleton County, and is irreplaceable
- The Forest has been declared Sacred to the Algonquin by Grandfather William Commanda
- The Forest is loved and valued by thousands across Ottawa and attracts tourists and their dollars to our City
- The Forest has Endangered and Threatened species, including coyotes, wolves, and possibly bears
- Hibernating wildlife will be driven from their homes and foodstores in the dead of winter, exposing many to a slow death by starvation and freezing, if cutting starts
- Rare plants and flowers will be destroyed, perhaps even some with medicinal value
- Tree-removal may cause flooding due to lack of tree-cover and vegetation, and may cause problems for nearby homes and wetlands
- Archaeological sites that are estimated to be up to 10,000years-old may be destroyed, eliminating a major source for understanding the past and destroying heritage
